

Victorian Child Safe Standard 8: Staff and volunteers are equipped with the knowledge, skills and awareness to keep children and young people safe through ongoing education and training.

Changes - What's different to our existing framework?

- This standard addresses the need to train and support staff and volunteers in protecting the 'wellbeing' of children and young people.
- CCYP have defined wellbeing as 'a positive state of physical, mental and emotional health. It generally means feeling safe, happy and healthy more than momentarily'.
- The PSU may need to revise policies to incorporate 'wellbeing' and is currently awaiting guidance from the Australian Catholic Safeguarding Limited on how 'wellbeing' is to be incorporated into child safe policies.
- Refer to the Self-Assessment Tool (Standard 7).

Implementation hints:

These implementation hints are not an exhaustive list, but are rather practical suggestions for bringing the standards to life within a parish. Some of these hints may not be relevant to your parish context, so you will need to contextualise the suggestions to reflect your parish setting.

- Develop a training action plan for staff and volunteers that includes training on:
 - the Child Safety and Wellbeing Policy
 - · identifying indicators of child abuse and harm
 - how to support a person making a disclosure about harm to a child
 - how to respond to issues of child safety, including internal and external reporting requirements, notifying families and carers, and managing risks to children
 - · how to support cultural safety.

This could be incorporated into your existing Self-Assessment Tool.

- Provide parish induction program information and/or a schedule.
- Maintain records of attendance at PSU training, including workshops, webinars and network meetings.
- Foster a culture of continual learning in the parish.
- · Share educational materials.
